RESOLUTION APPROVING TAX APPEAL SETTLEMENT WITH MERRILL CREEK

WHEREAS, Merrill Creek Reservoir is the owner of property known as Block 20, Lot 1, Q0101; Block 21, Lot 1; Block 24, Lots 1, 23, and 6; Block 300, Lot 2.01; Block 38, Lot 4; Block 39, Lot 35 and Block 9, Lots 56 and 57 on the Tax Map of the Township of Harmony; and

WHEREAS, there is located on said property a reservoir, dam and related structures and buildings; and

WHEREAS, Merrill Creek Reservoir had filed tax appeals for tax years 2011, 2012 and 2013 which were tried and decided by the State Tax Court and affirmed by the Appellate Division; and

WHEREAS, Merrill Creek Reservoir has filed a tax appeal contesting the assessment on said property for the years 2014, 2015, 2016, 2017, 2018, 2019, 2020 and 2021; and

WHEREAS, the combined assessment of the properties has been assessed at an amount of \$220,725,900.00; and

WHEREAS, the Township did retain the services of an outside appraiser, Louis Izenberg; and

WHEREAS, the tax payer produced an expert report with reference to its appraisal of the property; and

WHEREAS, the data was reviewed by the professional appraiser, as well as the Township Tax Assessor; and

WHEREAS, a settlement was negotiated, which has been recommended by the Township Attorney, the Tax Assessor and the outside appraiser; and

WHEREAS, the settlement was recommended as a way to resolve eight years of tax appeals without the need for a costly trial and also to set a value going forward for five additional years; and

WHEREAS, the Township is desirous of confirming said settlement;

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Harmony, County of Warren and State of New Jersey, that the settlement attached hereto is hereby approved.

ORDINANCE NO. 21-8 HARMONY TOWNSHIP WARREN COUNTY, NEW JERSEY

ORDINANCE OF THE TOWNSHIP OF HARMONY, COUNTY OF WARREN, STATE OF NEW JERSEY TO AMEND, REVISE AND SUPPLEMENT CHAPTER 156 "VEHICLES AND TRAFFIC," SECTION 33 "SPEED LIMITS" OF THE CODE OF THE TOWNSHIP OF HARMONY TO SET A SPEED LIMIT FOR PLEASANT HOLLOW ROAD.

WHEREAS, the Committee of the Township of Harmony has received a request from a resident to reduce the speed limit on Pleasant Hollow Road; and

WHEREAS, Pleasant Hollow Road is a very small street that connects to Harmony Brass Castle Road on both ends which should be driven as slow as possible; and

WHEREAS, the lowest speed restriction available to the Township is 25mph; and

WHEREAS, the Committee of the Township of Harmony, County of Warren, State of New Jersey, has determined that Chapter 156 "Vehicles and Traffic," Section 33 "Speed Limits" of the Code of the Township of Harmony shall be amended, revised and supplemented to set the speed limit for Pleasant Hollow Road to 25 mph.

NOW, THEREFORE, BE IT ORDAINED by the Committee of the Township of Harmony, County of Warren, State of New Jersey that Chapter 156 "Vehicles and Traffic," Section 33 "Speed Limits," of the Code of the Township of Harmony shall be amended, revised and supplemented as follows:

Section 1:

§ 156-33B shall be amended to add the following street to the list of speed restricted streets:

Section 2:

<u>Severability.</u> The various parts, sections and clauses of this Ordinance are hereby declared to be severable. If any part, sentence, paragraph, section or clause is adjudged unconstitutional or invalid by a court of competent jurisdiction, the remainder off this Ordinance shall not be affected thereby.

Section 3:

<u>Repealer</u>. Any ordinances or parts thereof in conflict with the provisions of this Ordinance are hereby repealed as to their inconsistencies only.

Section 6:

<u>Effective Date.</u> This Ordinance shall take effect upon final passage and publication as provided by law.
