ORDINANCE NO. 21-6 HARMONY TOWNSHIP WARREN COUNTY, NEW JERSEY

ORDINANCE OF THE TOWNSHIP OF HARMONY, COUNTY OF WARREN, STATE OF NEW JERSEY TO AMEND, REVISE AND SUPPLEMENT CHAPTER 110 "LAND USE PROCEDURES," ARTICLE II "LAND USE BOARD", SECTION 12, "APPLICATION PROCEDURES," OF THE CODE OF THE TOWNSHIP OF HARMONY TO CHANGE THE NUMBER OF CPIES REQUIRED TO BE SUBMITTED TO THE BOARD.

WHEREAS, the Committee of the Township of Harmony, County of Warren, State of New Jersey, has determined that Chapter 110 "Land Use Procedures," Article II "Land Use Board" Section 12, "Application Procedures," of the Code of the Township of Harmony shall be amended, revised and supplemented to change the number of copies required for submissions to the Land Use Board from 10 days to 16 and require one digital copy.

NOW, THEREFORE, BE IT ORDAINED by the Committee of the Township of Harmony, County of Warren, State of New Jersey that Chapter 110 "Land Use Procedures," Article II "Land Use Board" Section 12, "Application Procedures," of the Code of the Township of Harmony shall be amended, revised and supplemented as follows:

Section 1:

Chapter 110. LAND USE PROCEDURES

Article II. Land Use Board

§110-12. Application Procedures.

Applications for development within the jurisdiction of the Land Use Board pursuant to the provisions of P.L. 1975, c. 291,[1] shall be filed with the Secretary of the Land Use Board. The applicant shall file at least 30 days before the date of the regular monthly meeting of the Board 40 16 copies of a sketch plat and one digital copy; 10 16 copies of applications for minor subdivision approval and one digital copy; 10 16 copies of application for major subdivision approval and one digital copy or 10 16 copies of an application for site plan review, conditional use approval or

planned development and one digital copy. At the time of filing the application, but in no event less than 10 days prior to the date set for hearing, the applicant shall also file all plot plans, maps or other papers required by virtue of any provisions of this or any other chapter or any rule of the Land Use Board. The applicant shall obtain all necessary forms from the Secretary of the Land Use Board. The Secretary of the Board shall inform the applicant of the steps to be taken to initiate applications and of the regular meeting dates of the Board. The Board shall not conduct a hearing on any application until it has been determined that a complete application has been submitted.

Section 2:

<u>Severability.</u> The various parts, sections and clauses of this Ordinance are hereby declared to be severable. If any part, sentence, paragraph, section or clause is adjudged unconstitutional or invalid by a court of competent jurisdiction, the remainder off this Ordinance shall not be affected thereby.

Section 3:

<u>Repealer.</u> Any ordinances or parts thereof in conflict with the provisions of this Ordinance are hereby repealed as to their inconsistencies only.

Section 4:

<u>Effective Date.</u> This Ordinance shall take effect upon final passage and publication as provided by law.
