Dear Resident;

You are receiving this letter because you have previously been on our Townwide Cleanup List for personal pick up by our Road Department during our scheduled clean up weeks.

IF YOU DO NOT REQUIRE A PICK UP DO NOTHING!

I wanted to make you aware of the 2024 Clean up Week rules and regulations for curbside pick up:

- ONLY ONE CLEAN UP WILL TAKE PLACE IN 2024
- SR./DISABLED PICK UPS WILL START MAY 1ST.
- **YOU MUST BE ON THE PICK UP LIST NO LATER THAN APRIL 26TH! (THIS IS IMPORTANT BECAUSE IF YOU CALL AFTER THIS DATE YOU WILL NOT BE PLACED ON LIST, NO EXCEPTIONS)**
- YOU MUST BE A RESIDENT SR. CITIZEN (65+ years old) OR CURRENTLY DISABLED TO QUALIFY.
- ALL ITEMS MUST BE CURBSIDE OR AT THE END OF YOUR DRIVEWAY BY MAY 1ST . (Pick up will begin 6:30 a.m. on the 1ST). **NO EXCEPTIONS!**
- THE AMOUNT ALLOWED IS NO GREATER THAN 2 REGULAR PICK UP TRUCK 8' BED SIZE LOADS. (Your own personal items are only allowed from your Harmony Residence).
- IF THERE ARE ANY APPLIANCES YOU MUST PAY THE FEE LISTED IN THE CLEANUP BROCHURE TO THE TOWNSHIP PRIOR TO IT BEING PICKED UP
- IF THERE IS AN ITEM YOU DO NOT WANT TO GET PICKED UP, DO NOT LEAVE IT OUT! THE ROAD DEPARTMENT HAS THE RIGHT TO REFUSE ANY ITEM NOT MEETING WARREN COUNTY LANDFILL SPECIFICATIONS.
- READ THE ENCLOSED CAREFULLY TO MAKE SURE ALL ITEMS ARE ALLOWABLE.
- TOWNSHIP EMPLOYEES ARE NOT ALLOWED TO ENTER ANY PREMISES TO REMOVE ITEMS.
- REMEMBER TO BE PLACED ON THE PICK UP LIST CALL THE MUNICIPAL OFFICE BETWEEN 9-4 MONDAY-FRIDAY *BEFORE APRIL 26TH!* .
