ORDINANCE NO. O:26-09

ORDINANCE OF THE TOWNSHIP OF HARMONY, COUNTY OF WARREN, STATE OF NEW JERSEY, NAMING CERTAIN STREETS ALONG THE COUNTY ROUTE 519 (COMMONLY KNOWN AS “BELVIDERE ROAD”), PURSUANT TO THE RELEVANT PROVISIONS OF N.J.S.A. 40:67-1(k)

WHEREAS, the Township Committee of the Township of Harmony has received a request to assign a name to a private driveway that belongs to the Calvary Community Church, which is located along County Route 519 (commonly known as Belvidere Road) and cross street named Old Church Road; and

WHEREAS, as a matter of public safety, the Township Committee believes it is in the best interest of the residents of the Township to name this road, so that drivers and emergency responders may more easily identify the exact location in need of aid in the area; and

WHEREAS, pursuant to N.J.S.A. 40:67-1(k) the governing body has the power and authority to provide for the naming and the changing of the names of streets and highways as well as the erection of signs thereon.

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Harmony, County of Warren, State of New Jersey that the street, located along the County Route 519 (commonly known as “Belvidere Road”), and cross street named Old Church Road and under the ownership of the Calvary Community Church shall be referred to as follows:

SECTION I:

1. The road closest to County Route 519 shall be named as Grotenhuis Lane;

A copy of the legal description of the driveway subject to the name change is annexed hereto and made part hereof as Exhibit “A.”

SECTION II: Severability.

Each section, subsection, sentence, clause, and phrase of this Ordinance is declared to be an independent section, subsection, sentence, clause, and phrase, and finding or holding of any such portion of this Ordinance to be unconstitutional, void, or ineffective for any cause or reason shall not affect any other portion of this Ordinance.

SECTION III: Repealer.

Any ordinances or parts thereof in conflict with the provisions of this Ordinance are hereby repealed to the extent of any such conflict.

SECTION IV: Effective Date:

This Ordinance shall be in full force and effect from and after its adoption and any publication as may be required by law.

NOTICE

NOTICE is hereby given that the foregoing Ordinance was introduced to pass on first reading at a regular meeting of the Township Committee of the Township of Harmony held on May 5, 2026, and ordered published in accordance with the law. Said Ordinance will be considered for final reading and adoption at a regular meeting of the Township Committee to be held on June 2, 2026, at 6:00 p.m. or as soon thereafter as the Township Committee may hear this Ordinance at the Municipal Building, located at 3003 Belvidere Road, Phillipsburg, New Jersey 08865, at which time all persons interested may appear for or against the passage of said Ordinance.
